

ARTICLE XV ANTI-TRUST COMPLIANCE

SECTION 1. POLICY

It is the undeviating policy of the Association to comply strictly with the letter and spirit of all federal, state and applicable international trade regulations and antitrust laws. Any activities of the Association or Association-related actions of its staff, members, officers, directors or chapter officials which violate these regulations and laws are detrimental to the interests of the Association and are unequivocally contrary to Association policy.

### SECTION 2. IMPLEMENTATION

Implementation of the antitrust compliance policy of the Association shall include, but shall not be limited to, the following:

2.1 Association membership, directors and committee/alliance/division meetings shall be conducted pursuant to agendas distributed in advance to attendees; discussions shall be limited to agenda items; there shall be no substantive discussions of Association matters other than at membership, directors and committee/alliance/division meetings; minutes shall be distributed to attendees promptly.

2.2 All Association activities or discussions shall be avoided which might be construed as tending to: (1) raise, lower, or stabilize prices; (2) regulate production; (3) allocate markets; (4) encourage boycotts; (5) foster unfair trade practices; (6) assist monopolization; or in any way violate federal, state or applicable international trade regulations and antitrust laws.

2.3 No individual other than the Chair of the Board and Chief Executive Officer--whether staff, member, officer, director or committee/alliance/division official--is authorized to communicate on behalf of the Association to any person or firm outside the Association except with the explicit, unequivocal approval of the Chair of the Board or President. No such individual may bind or commit the Association to any offer, contract, policy, program, position or decision without that approval. And no such individual may hold out himself or herself, or willingly appear to do so, as representing the Association without that approval.

2.4 NGA legal counsel shall attend all NGA Board and membership meetings, either in person or via teleconference. Attendance of counsel at other meetings shall be at the discretion of the NGA Chair of the Board.

2.5 Association staff, members, officers, directors or committee/alliance/division officials who participate in conduct which the Board of Directors, by a two-thirds (2/3) majority vote, determines to be contrary to the Association anti-trust compliance policy shall be subject to disciplinary measures up to, and including, termination.

### **CONFLICTS OF INTEREST POLICY**


This Conflicts of Interest Policy applies to all National Glass Association (NGA) staff, members, officers, directors, chapter officials, and all members of a committee, division or task force of NGA as designated by the Board of Directors ("interested persons").

As an interested person, I recognize that I owe duties of care and loyalty to NGA. One aspect of fulfilling those duties is to avoid conflicts of interest in which my allegiance might be split between my position with NGA and some other personal, professional, or volunteer position or responsibility. To help avoid conflicts, I will disclose other situations or areas in which it might even appear that I have interests conflicting with those of NGA. I invite any further review by the NGA of any aspects of these situations or areas which might be considered appropriate.

Using the NGA Conflicts of Interest Disclosure Form provided by NGA staff, I will disclose potential conflicts to the Chair of the Board (or in the case of the Chair, to the Treasurer) and/or to the members of any committees, divisions or task forces of NGA as designated by the Board annually and as they arise. For each interest disclosed, the Chair (or Treasurer) will determine whether to: (a) take no action; (b) assure full disclosure to the Board of Directors and/or the relevant committee, division, or task force; (c) ask for recusal from participation in related discussions or decisions; or (d) ask for voluntary resignation from the Board, or, potentially, removal in accordance with NGA's removal procedures or voluntary resignation from the relevant committee, division or task force. NGA's CEO will also monitor proposed and ongoing transactions for potential conflicts of interest.

### Disclosure of interests:

Personal, professional, or volunteer positions or responsibilities, including those of mine and/or my family members, that might give rise to conflicts (examples include serving in a position of leadership for another association in the glass or residential window and door industry, or performing work for the NGA or another association in the glass or residential window and door industry).

### NGA Glass & Glazing Advocacy Days FAQs

Q: I thought I'd be meeting with my own Senators and Representatives—why weren't any of my meetings scheduled with them?

A: Congressional meetings are determined first and foremost in relation to NGA's policy priorities. Meetings are scheduled with your District or State legislators especially when our legislative consultants determine your legislator has a direct impact on one or more of our priorities.

Q: I would like to meet with Senators or Representatives, why were most of my Congressional meetings with staffers?

A: Meeting with a staffer does not mean the legislator doesn't care about the meeting or the issue. It simply means the he or she is not available due to the high demand on their time. Congressional aides are more available and very knowledgeable, and most importantly, have the trust of the legislator. A meeting with a staffer or aide can be as effective as a meeting with the legislator.

Q: I was surprised to be assigned to a large group for these meetings, I thought I'd be going to meetings on my own.

A: Legislative offices generally are more favorable to scheduling meetings when they get to meet with a group instead of just one or two individuals. We are aware that the group sizes for 2024 NGA Glass & Glazing Advocacy Days were larger than previous years and that created some challenges. We will aim to keep the group sizes a little smaller in future years.

Q: NGA's issues don't relate directly to my company, can't I just talk about my own company's needs during these meetings?

A: NGA's Glass & Glazing Advocacy Days is our industry's opportunity to talk about the priority issues that NGA and our legislative consultants feel will have the most impact on the entire glass industry and are directly related to current legislation. By taking part in Glass & Glazing Advocacy Days you are lending your voice to help NGA advance these priority issues. We need every Glass & Glazing Advocacy Days participant to stay focused on these priority issues to get our points across during these brief meetings. We recommend that you get in touch with your Senator or Representative by email or at their home office to discuss how they can help with issues directly related to your company.

### NGA Glass & Glazing Advocacy Days FAQs

Q: We have more than one location and I'd like to meet with offices representing our other locations too.

A: Beginning with future Glass & Glazing Advocacy Days, we will include more fields on the RSVP form to capture those additional locations' addresses from you and let our consultants know you are also available for meetings with those state/district representatives.

### Q: I didn't feel fully prepared on the issues and meeting schedules. Can we have more prep time?

A: <u>We hear you</u> and agree that participants should get more prep time. We will dedicate more time on Day 1 of the event to go over the priority issues and the one pagers. We will give groups more time to meet with each other on Day 1 to decide on roles and speaking points, and we will work with groups to discuss probable scenarios and what to do when things don't go well, and have dedicated time for Q&A.

### Q: I want to read the full bills that we are asking Congress to support.

A: Reference NGA's one-pagers in advance (always posted on glass.org/advocacy/initiatives/priorityissues) and see the current bills for which we are seeking support. Then go to <u>Congress.gov</u> and put the bill number (starting with H.R. or S.) in the search bar at the top and hit enter. Click on the corresponding search result to see an overview of the bill's progress. Click on the "Text" tab toward the bottom of the page to read the full bill.

### Q: Day 2 was a lot of work! Can our appointments start on Day 1 so we can spread them out?

A: The traditional Capitol Hill "fly in" model does make for a long and busy single day! It is incredibly difficult to schedule just one day of appointments; scheduling appointments on an additional day would not be ideal.

### Q: Shouldn't we be leaving a small token or gift at these meetings so that they remember NGA and our meetings? Maybe some NGA stickers or buttons?

A: There are very complicated rules surrounding federal legislators and their staff accepting even small gifts or tokens of appreciation and it is not encouraged in general. We do not want to run afoul of any of these rules or be seen negatively by the legislators' offices as trying to "buy favors." As such, NGA does not want Glass & Glazing Advocacy Days participants handing out anything other than the provided NGA one-pager documents and business cards.

### Q: What did we accomplish? Did we get any bills passed?

A: Good things often take time and lobbying Congress is no exception. While there is often no immediate "win" directly attributed from these meetings, they are not for nothing. It takes time and persistence to raise awareness of our industry and its unique needs, to build our reputation, and to identify champions in Congress who can help further our reach. Laying that foundation now by educating them on our issues and asking for their support on our priorities, greatly increases our chances for getting positive votes in the future when bills important to our industry make their way to the House and Senate floor.
